Orange County Council Meeting Minutes SCREC May 24, 2011

The meeting was opened by Alex Martin at 7:14 p.m.

The **Pledge to the American Flag** was led by Jake Hetherington and the **4-H Pledge** was led by Ashleigh Mathias.

Officer's reports:

President – None at this time

Vice President – Phil Pacia said that he would share information about the La Habra Fair later and that Ginny Houtz will have her Show-N-Tell about her WRLF cruise later this evening as the Program.

Treasurer – Jim Mullion was not present. Alex reported that the balance in the checking account is \$12,239.43 and the savings account has \$10,759.37.

Recording Secretary – Beverly Schrieber submitted the minutes and they were approved.

Corresponding Secretary – Shar Rice had nothing new to report.

Youth Representatives – B. J. Bender said that she is still collecting for the Terracycle county fundraiser. She said thank you to everyone who has donated. Ashleigh Mathias reported that she did not spend the \$50.00 on the South Section Field Day Food Booth as expected. She will return it to the council.

4-H County Representative – Jeanne Lothridge is out of town. She will return the second week in June. **Old Business**

All Star / Ambassadors / Teen Council – Alex Martin said the Applications are due to Mary Kerr by May 31st. mkerr@fjuhsd.net.

By-Law Amendment Approval – Alex explained that this was e-mailed out prior to the Council Mtg last month and again yesterday. We need to vote to approve the amendment tonight so it can be signed and approved by the State in this 4-H year. The changes are on page 2, 6 and 7. Excerpt pages with just the changes are on the back table and are shown below.

Article II

Officers

Section 1 -- Officer Positions

The officers of the County 4-H County Council shall consist of a president, vice-president(s), secretary(ies), treasurer(s), Youth Representatives and such others, as the 4-H County Council deems necessary. These officers will make up the Executive Board.

Other officers either elected or appointed such as immediate past president, reporter, historian and organizational unit leader.

Section 2 -- Eligibility and Term of Office

An office shall not be held by the same person for more than two consecutive terms years. A term will be two (2) years in length, with offices alternating election years. (2011-12 year election shall be President and Secretary for two (2) years, Vice President, Treasurer and Corresponding Secretary for one (1) year. 2012-13 year election shall be Vice President, Treasurer and Corresponding Secretary for two (2) years.) This may be extended by the Executive Board as deemed necessary with approval of 4-H YDP Staff and the County Director. Elections should be held at the end of the 4-H year or soon after the beginning of the new 4-H year.

Section 4 -- Duties of Officers

F. Youth Representatives

It shall be the duty of the Youth Representatives to:

- Take notes and bring information back to their respective clubs.
- Provide leadership as necessary for various County Activities as requested by the County
 Executive Board and County Council President.
- Identify and lead (as a group or individually) at least one Community Service Activity that can involve all youth (who wish to participate) in Orange County 4-H.
- Identify and lead (as a group or individually) at least one Fundraiser that benefits Orange County 4-H.
- Participate in County Junior / Teen Leadership Workshops as time permits.
- Attend regular Executive Board meetings.

Article III Elections

Section 1 – Nominations

A nominating committee shall nominate officers, youth representatives and sectional representatives of the 4-H County Council. Additional nominations shall be called for from the floor before balloting begins.

Section 2 – Balloting for Officers

Elections shall take place by written or electronic ballot unless the 4-H County Council by majority vote of those present specifies otherwise declared elected. Balloting shall be limited to active leaders and senior 4-H members age 14 and above.

After lengthy discussion, a **motion** was made by Melodie Bramstedt, seconded by Tracy Rice and passed, to change **Article II**, **Section 2** to read as follows: "An office shall not be held by the same person for more than one consecutive term. A term will be two (2) years in length, with offices alternating election years. (2011-12 year election shall be President and Secretary for two (2) years, Vice President, Treasurer and Corresponding Secretary for one (1) year. 2012-13 year election shall be Vice President, Treasurer and Corresponding Secretary for two (2) years.) This may be extended by the Executive Board as deemed necessary with approval of 4-H YDP Staff and the County Director. Elections should be held at the end of the 4-H year or soon after the beginning of the new 4-H year."

Also a **motion** was made by Richard Schrieber, seconded by Kay Strothman and passed to change a portion of **Article I, Section 2, A, 1** from "Senior 4-H members (9th grade – 12th grade or age 14 and above by December 31st of the current 4-H year shall be eligible to be active members of the 4-H County Council". To "Senior 4-H members (9th grade – 12th grade or age 14 and above by December 31st of the current 4-H year, shall be active members of the 4-H County Council." All that was done was to remove the words "eligible to be".

A motion was made by Tracy Rice, seconded by Karen Pascoe, to change Article II, Section 1 by adding the word "two" before Youth Representatives and to leave the existing wording unchanged in Article II, Section 4, F. In addition, Article III, Section 1, will have the words "youth representatives" removed and the following sentence added. "The 4-H Teen Council will nominate members for the Youth Representative positions to be voted in the first County Council meeting of the year and they will hold the duties of the Youth Representatives as defined in Article II, Section 4,F". This motion passed. There were 12 in favor and 6 opposed to this motion.

Article III, Section 2, will remain unchanged.

A **motion** was made by Richard Schrieber, seconded by Phil Pacia and passed to approve the By-Laws as amended this evening.

OC Fair – Alex stated that all large livestock members need to be enrolled in those projects through the on-line registration. If your members did not get enrolled in those projects, you will need to follow up with Jeanne Lothridge or Scott Osborne. Only enrolled participants can show animals at Market Week. The Registration books were sent out by e-mail to everyone. Alex resent them today along with the OC Fair Code of Conduct form. The livestock entries need to be completed, printed and signed by the club leaders and mailed to the OC Fair along with the signed Code of Conduct no later than June 10. Building entries need to be done and paid for no later than June 1st. Alex brought copies of a Fair calendar as it affects 4-H, both building entries and livestock. Jan Tubbiola mentioned that someone will be at the Fair office to help with registration on Wednesday, Thursday and Friday of this week from 1-6 p.m. This information is also available at http://www.ocfair.com/2011/ Online Entry Deadline: - June 1, 2011 - Entry Help Days: - May 25 - 27, 1 pm - 6 pm - May 31 - June 1, 1 pm - 6 pm - Online Livestock Entry Deadline: June 10, 2011.

La Habra Valley Community Fair – June 10-12 – The entry website opened for registration is http://www.lhvcfair.com/. There will be a sanction dog show and youth dog show, large livestock, poultry, rabbits, cavies, youth building entries. A Livestock Code of Ethics form will be required with your livestock entry. The catalogues were e-mailed out today. Entry forms are due June 1st. Phil Pacia said that all of the Community Club leaders will receive information about your members entries. You will need to verify that the member is in good standing. If there is a question, call Phil.

Record Book Workshop – June 18th, 9 am.-Noon at SCREC. An e-mail was sent out today with template forms for the record book and a worksheet to use for the workshop for planning out your information. **State Leadership Conference** – registration is due by June 17th. It will be held July 28-31 at the UC Davis Campus. There are scholarships available for this unless they went to TIC.
