Committee Reports

The event will be from 9 a.m. to approx. noon. The event is open to primary members, 4-H youth enrolled in Food related projects (like Foods, Food Preservation, Cake Decorating). Master Poultry Update —Tracy Rice and B.J. Bender reported that they have raised \$1,100.00 so far for the Orange County Master Poultry Team. They would like to request the remaining amount of \$3,000.00 from the County Council as we were instructed last year. We have been and still are studying and we are very excited for our trip to Nationals in Kentucky this coming November 16-18. Budget Request forms must be completed before this can be handled.

Presentation Day – This event will be on Saturday, March 5, 2011, at Montessori on the Lake, 23311 Muirlands, Lake Forest, 92630 (Same place the last 2 years). The planning meetings will be on the first Wednesdays each month, starting in Nov. at Montessori on the Lake.

Youth Expo – We have a tentative date of Friday-Sunday, April 8-10, 2011 at the Orange County Fairgrounds. E-mails will be coming to the committee members from last year and any other interested volunteers.

Sectional / State Reports – Ginny Houtz stated that at the Sept. 11 meeting elections were held. The officers are President- *Tony Burkhardt-Riverside Co, V. The * indicates re-elected for second term. Mandy Bottoms is new on state staff for the Healthy Living Initiative. Steve Dasher reported that the UC Administration has a good relationship with 4-H, a couple are former 4-H members. Noel Keller, L.A. Co, is chairman for the Sectional Field Day, May 21, 2011. TIC will be January 14-16, 2011. Leaders need to check when applications are due for State committees. There are openings on several, particularly some that would represent South Section. Some also have money to reimburse transportation expenses. Horse Advisory Committee is a committee of South Section and they now have a line item in the budget. Tech Team member John Trammell announced that there will be a Photography Contest at State Field Day. Information will be available in January. Remember State Leaders Forum, Nov. 5-7. Registration is \$45 until October 1st.

Awards & Incentives – Kay Strothman reported that all of the Primary, Junior, Intermediate and Senior Record books have been judged. They have been returned to the clubs. The Senior Record books that will be going to state for further competition and are due back at the 4-H office by October 20th. They will be judged at state on the first weekend in December. We have a November 5th postmark deadline for sending the books to state. The Club Officer books have also been judged.

New Leader Orientation – Ginny Houtz announced that this training will be taking place on October 23^{rd} from 9-12 at SCREC and again on Thursday, Nov. 18^{th} from 7-9 p.m., also at SCREC. Please let the 4-H office know who will be attending each orientation so that they may be prepared with the Life Scan fingerprinting paperwork.

Goats would be wonderful because no one has brought goats yet. Students have seen chickens often and rabbits and horses, etc. The children may love to pet them or be too shy. Jordan is a school for the handicapped children of Orange County. Some are blind, some are in wheelchairs, and are of a great range of abilities. Your program does not have to be complicated. Phil Pacia said that we would like to expand the committee and have it work well without having the county council officers carry the load. Yes, we have wonderful foundations that respond to the letters; however, we need to develop this committee to generate new sources of income.

Summer Camp – Joe Cole said that at the moment the summer camp is defunct. We are attempting to see about arrangements to have a joint camp with Riverside County. We need more kids for the camp.

Winter Camp – Need someone to chair this event. It is for members 14 years old and older. Usually the AllStars/Ambassadors plan this camp. We need at least 11 members for the camp to pay for itself. We also need one chaperone per 4 kids. It has been held on Martin Luther King holiday in January.

AllStar/Ambassadors -- Alex said that Jeanie said that no one has applied so far this year. We need an adult advisor to lead this team. B.J. Bender is willing to help with the planning of Winter Camp if we can find an advisor. The other 3 youth

reps will be happy to plan also when the program gets off the ground. Any adult volunteers are encouraged to contact Alex Martin.
