# Orange County 4-H Council Meeting – SCREC – Tuesday, November 23, 2010 Tentative Minutes

Leader's Banquet – Jan Tubbiola reported that she wanted to request new participation on the Leaders' Banquet Committee. We have had the same people doing this job for many years, and these people have really enjoyed the meetings and the results of their planning. We feel that we have provided some fantastic speakers the past few years from all over the country. However, the participation has not matched the effort. We are requesting new blood on the committee. Although we have tried many attempts at a new venue and new times, we haven't succeeded in getting the participation. Due to circumstances beyond our control, we are losing

valuable members on the committee. We have two requests, (1. New members on the committee 2. An idea to piggy-back another event.) Even though we feel it is important to recognize the efforts and talents of our leaders, only a core group attends. It is a conference that is focused on Leadership and Citizenship skills. It is scheduled to be held **January 14-16, 2011** at Pathfinder Ranch. We have a \$50 scholarship from the Suzanne Guthrie Memorial Fund per applicant on a first come, first serve basis. 5 or 6 members have already said that they plan to attend.
