## To Parties of the Renewables Portfolio Standard ("RPS") Rulemaking (R.18-07-003).

Pursuant to Decision (D).14-12-081 and the Energy Division Director's November 28, 2017 to the Investor Owned Utilities, a review of the Bioenergy Market Adjusting Tariff (BioMAT) program was initiated. <u>Energy Division staff is requesting informal comments and reply comments on Staff's BioMAT</u> <u>Program Review and Staff Proposal</u>. This document describes Energy Division staff's key observations about program performance to-date, sets a timeline for the program review, lays out Energy Division's straw proposal for program changes, and poses questions to stakeholders. Energy Division staff will use stakeholder comments to inform the scope and content of future workshops and revisions to the straw proposal that the Commission can consider in the RPS proceeding.

Please note that Energy Division staff is opening the opportunity to comment to any interested stakeholders, and not just parties to this proceeding. Any stakeholder that wishes to file informal comments or reply comments may do so and does not have to be a party to this proceeding.
