Hello, my name is Gabriel Torres. February 1, 2018, I started as the Viticulture Farm Advisor for Tulare and Kings Counties. I am originally from Colombia where I obtained my bachelor's degree in Agronomy/Plant Science in 2007. I worked as a researcher at the Colombian National Oil Palm Research Center (Cenipalma) from 2007-2010. I then came to the United States and started my PhD. program in Plant Pathology at Michigan State University in 2010. I went back to Colombia in 2014 and served as leader of the Oil Palm Diseases Program at Cenipalma for two years. After my graduation at MSU in 2016, I was invited by Dr. Andreas Westphal (UC Riverside) to be part of his team to conduct nematodes research in grapes at the Kearney Agricultural Research and Extension Center.
