<sup>1</sup> The amount of water required by a specific irrigation system to satisfy evapotranspiration. Typical ranges in irrigation system efficiency are: Drip, 80%-95%; Micro-sprinkler, 80%-90%; Sprinkler, 70%-85%; and Flood, 50%-75%.

<sup>\*</sup> Estimates are for orchard/vineyard floor conditions where vegetation is managed by some combination of strip applications of herbicides, frequent mowing or tillage, and by mid and late season shading. Weekly estimates of soil moisture loss can be as much as 25 percent higher in orchards where cover crops are planted and managed more intensively for maximum growth.
