Returning adult volunteers must be complete in 4honline by February 8<sup>th</sup> as the system will remove "inactive" volunteers! This means you will need to start the 4-H adult volunteer process all over again. The 4-H office is open to help adults by appointment. ## **4-H Adult Re-appointment Process**

1. Begin the 4-H adult volunteer re-application process in 4hOnline: Login to family profile at <https://ca.4honline.com>. Login to adult record and click “Enroll for 2019-2020”. Enter all required information and submit. 4hOnline adult status will show as pending.
  - a. Once adult status is pending in 4hOnline, an email will be sent from 4HOnline with instructions to take the required trainings in eXtension along with the county enrollment key. (Monterey) Check junk or spam folder if this email is not in the inbox. If needed, the enrollment can be requested by clicking on this link:

2. Complete the required “2019-2020 Returning Volunteers Training” in eXtension
3. Go to <https://campus.extension.org/course/view.php?id=1537> –ENGLISH VERSION or <https://campus.extension.org/course/view.php?id=1500> –SPANISH VERSION
  - a. Maintaining an Inclusive 4-H Experience (10 min)
  - b. Abuse Risk Management for Volunteers (15 min)
4. Submit fee payment to the Camp Director.
5. The application is reviewed by 4-H YDP staff & the County Director
  - a. If approved, notification of your 4-H adult volunteer appointment will be sent from 4hOnline.
  - b. If there are any limitations on the appointment a subsequent letter will be sent from the County Director.
6. Camp Directors will be able to contact the 4-H offices to confirm you have been accepted as an adult volunteer before the county deadline on February 8<sup>th</sup>, 2020.
