

# 2020 John Haggerty Memorial 4-H Council Scholarship

## **Purpose of Scholarship**

• The UC 4-H Youth Development Program is committed to promoting higher education. This scholarship award serves to recognize youth for their achievements in 4-H and in their community. In previous years, the award granted has generally ranged between \$500 to \$1,000 each.

### **Applicant Qualifications**

- Must presently be an active 4-H youth member in Santa Clara County.
- Must have been enrolled in 4-H since July 2018 and a member in good standing.
- Must be enrolled, or planning to enroll, in at least half of the full-time course load as defined by the applicant institution.
- May only receive this scholarship once.

### **Required Items**

- 1) Completed online application submission, including essay questions @ http://ucanr.edu/JHS
- 2) Uploaded documents, including:

A) Resume (4-H resume) – Refer to this site for instructions: http://4h.ucanr.edu/Resources/Member Resources/4-H Resumes/

B) Proof of enrollment in OR a letter of acceptance to an institution of higher education.

C) Application Agreement, signed by both a parent/guardian AND you, the applicant.

- 3) Two completed Recommendation surveys. Provide your references the link to complete on your behalf @ http://ucanr.edu/JHSR . Your references must be one 4-H volunteer and one other adult. Your references will reflect and report on your qualities of Competence, Connection, Character, Caring, Confidence, and Contribution. References *may not* be a family member.
- 4) Interview, if necessary date to be determined (may be conducted by Zoom).

- ✓ NO late applications and NO walk-ins/drop-offs will be accepted.
- ✓ Award selection notification will be sent out by July 15, 2020 via email.
