Agenda Review & Accept Motion made by Shauna Jones to accept the agenda, 2nd by Marci Sanchez. Unanimously approved by attendees.

- 4-H Fundraiser Dinner Event Committee Recap Willows 4-H Club Chair: Abby Alves, Corie Hurlburt, Debbie Scritchfield Jamie Hobbs, and Holly Pool. Abby Alves reported a Profit of \$11,XXX. The Bake Sale did well @ \$2,083. Expenses were a bit higher this year than last, but it was due to purchasing a few one-time items like scales and scoops. Abby shared that something discussed at the wrap-up meeting was we need other clubs to participate. There wasn't anyone for the 2nd shift and members from the first shift stayed over to cover it.

- Glenn County 4-H Council Committee Sign-ups- Chair, Marci Sanchez states there is a new survey to come out but has not yet. She would like to get working on calendar of events right after fair.

- Ambassador/ Junior Ambassador/ Scholarship/ Leadership Development Award-Per Christine there has been some applicants and leadership awards however no ambassador or Jr Ambassador at this time.
