#### Who can RSVP? Who is this for?

- This opportunity is for Ag youth-related organizations, their membership, and their families. The two biggest participants are FFA chapters and 4-H clubs, but are not limited to those. To inquire about whether your organization qualifies, reply to this email.

#### Does this cost any money? How does it work?

No, this opportunity is completely free. Each FFA chapter, 4-H club, and/or other Ag
youth-related organization will be issued vouchers to distribute to their membership &
families, which are then turned in at the games for a free ticket (and possibly a t-shirt).

#### How should I collect my RSVP headcount?

 Inform each member of your organization (the youth) & related administrators about the games. Ask them to check with their families to determine if they'd are able to attend and would like to go. Keep an accurate, itemized count.

#### Do I need to get a separate RSVP headcount for each game?

 No, we only need a grand total including both games. The vouchers will be applicable to either contest.

#### Can we go to BOTH games if we want to?

- Yes. Make sure to collect RSVPs appropriately – so a family of four going to both would equate to 8 voucher RSVPs. We also ask that families attending both games only claim t-shirts at one of the games, should they arrive early enough to get them.

#### How should I communicate my RSVP count to CSUB?

- Reply to this email with your RSVP headcount by Friday, February 3rd if possible.

#### How will I get our vouchers so I can hand them out?

- If your organization is tied into the Kern HS District Ag Coordinator (Clay Freeman), which is most Kern FFA chapters, we will verify if he will be delivering your vouchers and when. ### 4-H SHOOTING SPORTS – HUNTING PROJECT/ CALIFORNIA HUNTER EDUCATION COURSE

This project covers the information required to take the California hunter education test and obtain your hunter safety certificate. The hunter safety certificate allows you to purchase a hunting license or hunt in other states that require proof of having passed a hunter education course. The project is open to junior, intermediate, and senior 4-H members. The five class sessions will take place at the Woody Community Hall at the intersection of Glennville Road and Woody Road. Students need to bring a writing utensil and paper to each class.

At the end of this course, each student is expected to demonstrate proper safety procedures with firearms and pass the written exam with a minimum passing score of 80% or better. Failure to pass the written exam prohibits the student from obtaining his/her hunter safety certificate, and she/he must retake the entire course. State law requires that each student attend every session. Missing one or more class sessions automatically drops the student from the course. Being tardy for class is also grounds for dropping a student.

Class size is limited to 25 students. 

### **Explorers of the Deep**

Explorers of the Deep, focuses on the mysteries and adventures of ocean exploration—with robots! Young people learn how to use science, technology, engineering, and math (STEM) to explore Earth's Ocean and how it relates to all life on the planet.

Explorers of the Deep activities can be done all at once or individually.

- 1. **Ocean Robot Test Tank** is an activity where youth learn how to "ballast" their ocean robot by adding weights to replicate the sinking and floating behavior of a real ocean robot. They will investigate data collected by ocean robots and learn about the value of ocean exploration.
- 2. **Ocean Expedition** is a board game where youth navigate their ocean robot around the world while learning key ocean concepts. Topics include aquaculture, climate change, innovation, human impact and the ocean ecosystem.
- 3. **Ocean Communicator** is an activity in which young people investigate challenges that ocean scientists, engineers and technologists are currently exploring. They design and advocate for innovations and technical solutions that inspire public action.


## **Design and Build a Solar Car**



## **Youth Loans**

FACT SHEET August 2019

#### Overview

The U.S. Department of Agriculture's Farm Service Agency (FSA) makes operating loans of up to \$5,000 to eligible individual youths ages 10 to 20 to finance income-producing, agriculture-related projects. The project must be of modest size, educational, and initiated, developed, and carried out by youths participating in 4-H clubs, FFA, tribal youth organizations, or similar agricultural-affiliated groups.

The project must be an organized and supervised program of work. It must be planned and operated with the assistance of the organization advisor, produce sufficient income to repay the loan, and provide the youth with practical business and educational experience in agriculture-related skills.

### Who May Borrow

To qualify for a loan, the applicant must:

- Comply with FSA's general eligibility requirements;
   and
- Conduct a modest income-producing project in a supervised program of work.



### **How Loan Funds May Be Used**

These loans can finance many kinds of income-producing agricultural projects. The loan funds may be used to:

- Buy livestock, seed, equipment, and supplies;
- Buy, rent, or repair needed tools and equipment; and
- · Pay operating expenses for the project.

#### **How It Works**

To apply, the applicant must submit completed plans and budgets signed by the project advisor and parent or guardian along with the FSA application for loan assistance.

#### These loans

- Have a maximum loan amount of \$5,000 (total principal balance owed at any one time cannot exceed this amount);
- Have an interest rate that is determined based on the cost of money to the federal government (after the loan is made, the interest rate for that loan will not change);
- Will be secured, in addition to promissory notes, by liens on the products produced for sale and on chattel property, including livestock, equipment, and fixtures purchased with loan funds; and
- Have a repayment schedule that varies depending on the type of project for which the loan is made. For example, if it involves raising livestock or crops, the loan is paid when the animals or produce are normally sold.
